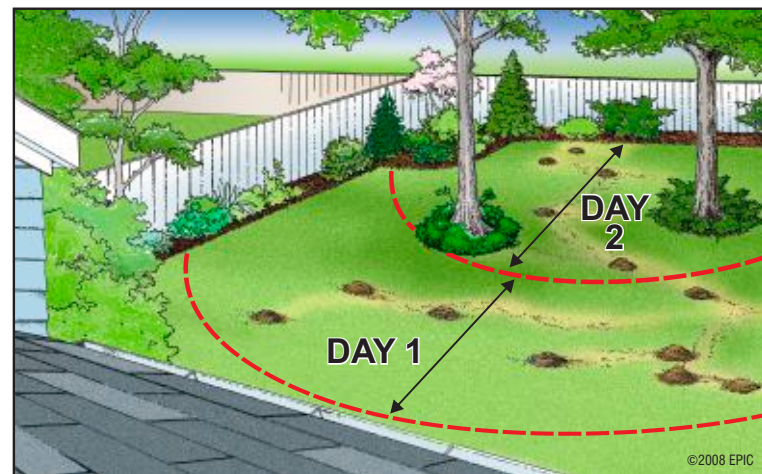
GENERAL APPLICATION:

Determine where you would like the moles to exit your property (refer to the diagram for guidance).

DAY 1 Starting at the point furthest from the exit point, apply **Mole Scram™** on and around the mole infested area, water for 20 minutes.

DAY 2 Apply **Mole Scram™** to the remaining area near the desired exit, water for 20 minutes.

Where possible, locate mole runways, then punch 1" holes every 10 ft., drop granules into the holes and cover with soil. **Also apply** to the end of each runway and visible holes made by the moles. **Apply 1 lb. per 750 sq. ft.**



NOTE: While Mole Scram is fast acting, it may take a few days for moles to associate their discomfort with the treated areas. Watering or rainfall is the key to activation as it draws the active oils from the granules into the soil. This action rapidly begins the repelling process.

FREQUENCY OF USE:

Mole Scram™ should be applied whenever mole activity - new tunneling - is observed. Mole Scram can also be applied to prevent mole damage at the beginning of Spring and then Fall, the two highest mole activity seasons. Use when soil becomes moist, even during a wet summer season, **BEFORE** moles begin tunneling.

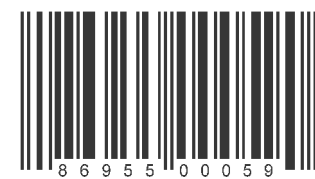
