#### **GENERAL APPLICATION:**

Apply directly onto plants, shrubs, trees and other landscaped areas. Avoid spraying in the mornings or after rain or irrigation if moisture is present on the plants. We recommend not spraying in high winds. Repeat in 15-20 days. For ongoing prevention, re-apply 30 to 45 days.

#### FOR TREE FARMS & NURSERIES:

Apply directly to seedling and sapling tree's branch limbs and leaves on the first 4 rows. Apply to the soil under the trees and out to 5 feet past the drip lines. Repeat in 15-20 days.

**GROWERS & NURSERIES:** Apply directly on the first 4 (four) rows of low growing plants & ornamentals. Spray a 5 foot barrier on the soil along the edge of the protected areas. Repeat in 15-20 days.

While NMPro Liquid Rabbit Repellent does not wash off easily in rain or regular irrigation; it should be reapplied immediately following periods of heavy downpour or consistent rainfall.
