Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. In case of contact, immediately flush eyes or skin with plenty of water. Applicators and other handlers must wear coveralls, chemical-resistant gloves, such as barrier laminate, nitrile rubber, or neoprene rubber or viton, and shoes plus socks. User Safety Recommendations

This product is toxic to fish, birds, and other wildlife. Do not contaminate water when disposing of equipment washwaters. Apply this product only as specified on this label.

PHYSICAL AND CHEMICAL HAZARDS

Do not use, or store near heat or open flame. Exposure to temperatures above 130°F, may cause bursting.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

In mustroom production and processing: To control mushroom flies of fungus gnats in growing houses, apply at a vate of 1 ounce per 1,000 cubic feet of space. Fogger should be operated 8 to 10 feet away from beds and directed slightly upward over them. Circulating fans should be left in operation but for the activities a control mushroom should be turned off. In packing and canning plants, use at a rate of 1 ounce to 2,000 cubic feet of space.

The use of this product in food processing establishments should be confined to time periods when the plant is not in operation. Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. Stored food products which are infested should be furnigated or treated by other effective methods using an approved product intended for that purpose.

Space Spray: For control of accessible, exposed stages of flies, including fruit flies, mosquitoes, small flying moths, gnats, wasps, hornets, cheese skippers, and these common stored product pests: granary weevils, rice weevils, confused flour beetles, saw-toothed grain beetles, spider beetles, cigarette beetles, Drugstore beetles, Angoumois grain moths, Mediterranean flour moths, Indian meal moths, Tobacco moths, meal worms, and grain mites: Close windows and doors and shut off ventilating systems. Use a fogger or vaporize adjusted to delive an aerosol spray (no droplets over 50 microns in diameter and 80% less than 30 microns). Apply at a rate of 1 office per 1,000 cubic feet of space Direct spray toward the ceiling and upper corners of the area and behind obstructions. For best control of wasps and hornets, apply directly to nests in the evening when the insects have returned to the nests. Keep the area closed for at least 15 minutes. Vacate the treated area and ventilate before reoccupying. Repeat treatment as necessary.

Space and Contact Spray: For control of accessible exposed stages of silverfish, crickets, roaches, spides, scorpions, clover mites, cheese mites carvigs, and ants first being equipment which can deriver a pin spray, direct spray into all cracks and crevices in woodwork, walls, floors underneath sinks, behind pipes and in all places where these insects are known to seek shetter. Contact as many insects as possible, spray directly all ant trails. Do not allow spray to contact stored food. Then, shutting all doors, windows and shutting off all vertilating systems proceed with space spraying directions as give above. Use a dosage rate of 1 ounce per 1000 cubic feet of space. Keep the area closed for at least 15 minutes. Vacate the treated area and ventilate before reoccupying. Repeat treatment as necessary.

For use on Animals: To protect beet and dairy cattle and horses from horn flies, house flies, mosquitoes and gnats, apply a light mist sufficient to we the tips of the hair. To control stable flies, horn flies and deer flies on beet and dairy cattle and horses, apply 2 oz. Per adult animal, sufficient to wet the hair but not to soak the hide.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited.

STORAGE: If container is damaged: Stop any leaks by repositioning the container or by patching or otherwise repairing the leaks. Take care to avoid contact with pesticide and wear protective gear. On cleanup of spilled liquids, wear protective equipment as required to prevent contact with the product or its vapors. Cover the spilled areas with generous amounts of absorbent material, such as clay, diatomaceous earth, sand or sawdust. Sweep the contaminated absorbent on to a shovel and put the sweepings into a salvage drum. Dispose of wastes as below. Place any leaking container into a similar drum or glass container. Do not store, use, pour or spill near heat or open flame. Do not store in car trunk where temperatures may exceed 120° F.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
