GENERAL INFORMATION – Alligare Surface is a general purpose nonionic surfactant, used to enhance spreading and coverage of sprays. Alligare Surface may be used with various insecticides, fungicides, herbicides, PGR's and nutrients at rates determined by pesticide label and field experience.

DIRECTIONS FOR USE – The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using Alligare Surface, the applicator or crops advisor must have experience with the pesticide combination, including Alligare Surface, or must have conducted a phytotoxicity test.

Utility ROW and roadside foliar	1/2 pt. - 2 qt.	0.5 - 4 tsp.
Forest site preparation	1 pt. - 2 qt./acre	1 - 4 tsp.
Aquatic - surface	1/2 pt. - 2 qt.	0.5 - 4 tsp.
Aquatic - submerged	1 - 2 gal.	2.5 - 5 tbsps.
Agriculture / Citrus / Turf	1/2 - 4 pt.	0.5 - 4 tsp.

MIXING – In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension and microencapsulated (LC, SC, ME)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL: Protect product from freezing. If product freezes, warm to room temperature before use. Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
