Application Instructions: **DAY 1:** Apply NM Professional Goose Repellent with a Spreader. **Open the Spreader to the largest open setting.**

Coverage is 350 square feet per lb. (7500 sq. ft for full use of 22 lbs). **DAY 14:** Repeat Day 1 applications.

For Lawns, Open Areas, Fairways: Apply where geese are landing. Geese will usually land in the same areas and begin eating and grazing. **For Lakesides & Pond Edges:** Apply along the water's edge where geese are exiting and entering lakes & ponds. Cover entire area plus 10 feet beyond where the geese traffic and grazing pattern are noticed. **For Golf Tee's and Fringes:** Cover the tee areas & the sides of the tees. Apply around the greens on the fringe areas (being careful not to put on the greens. *Note: This product will not hurt the greens, but the granular formula makes it difficult to putt on.* **For walkways, curbsides:** Apply along the dripline or edge where grass meets pavement. This product adheres to grass and soil. **RESULTS** Geese should have moved to another location or left the area entirely.
