Section V - Health Hazard Information

ACUTE ORAL LD50: Rat >5000mg/kg

PRECAUTIONS: Do not contaminate feed or food. Keep out of reach of children. Should poisoning occur, obtain prompt medical aid. Prolonged exposure will result in cholinesterase depression. Always practice good hygiene when using this or any chemical. Wash thoroughly with soap and water after contact.

FIRST AID PROCEDURES: IF IN EYES: Flush eyes with water for at least 15 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. **IF SWALLOWED:** Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person. **IF INHALED:** Remove to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention. **IF ON SKIN:** Remove contaminated clothing and wash skin immediately with soap and warm water. If irritation occurs, get medical attention.

Section VI - Precautions for Safe Handling/Use

STORAGE: Store in a cool, dry place and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food and feed. Store in original container and out of the reach of children, preferably in a locked storage area.

PERSONAL PROTECTIONS AND CONTROL MEASURES: EYE PROTECTION: Safety glasses or goggles.

OTHER PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed, inhaled or absorbed through skin. Causes mild eye irritation. Avoid breathing vapor or dust. Wash thoroughly after handling. Launder clothing daily after use.

Section VII - Environmental and Disposal Information

SPILL OR LEAK PROCEDURES: Handle open container in a manner as to prevent spillage. If the container is leaking or material is spilled for any reason or cause, carefully sweep material into a pile. Refer to Precautionary Statements on label for hazards associated with the handling of this material. Do not walk through spilled material. Keep unauthorized people away.
