Skin Contact

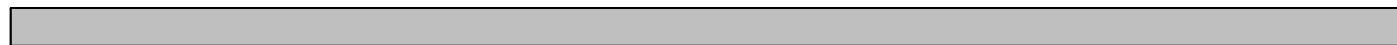
