### 4. First-Aid Measures

A marked decrease in body weight gain and an increase in benign thyroid proliferative lesions were observed in the lifetime rat study at the highest dose tested. The substance is not considered to pose a carcinogenic risk at low human exposure levels.*

Cases have been described of orange-yellow colouration of urine following heavy exposure of workers to the dust of pendimethalin. Despite its structure as both a nitro-compound and aromatic amine, exposure to pendimethalin is NOT associated with methemoglobinemia.
