Best Practices when using NyGuard® EZ1

Use NyGuard EZ1 as part of an IPM Program

Use NyGuard[®] EZ1 as part of an Integrated Pest Management (IPM) program to break the cycle of insect reproduction. NyGuard EZ1 gets to the root cause of insect problems – the eggs, larvae or nymphs – and prevents them from maturing into reproductive adults. NyGuard EZ1 will cause morphological abnormalities and disrupt the normal development of immature stages of insects, leading to sterility or death.

IGRs do not typically result in immediate reduction of insect populations. If immediate insect population reduction is desired, use NyGuard EZ1 in a tank mix with an adulticide (such as Onslaught[®]) that will deliver immediate results.
