**SECTION 4 - FIRST MEASURES**

**SECTION 12 - ECOLOGICAL INFORMATION**

**ENVIRONMENTAL SUMMARY:** This product is toxic to fish and aquatic invertebrates and may adversely affect non-target plants. Do not apply directly to water, to areas where surface water is present, or to intertidal areas below the mean high water mark. Drift and runoff may be hazardous to aquatic organisms in water adjacent to treated areas. Do not contaminate water when disposing of equipment washwaters or rinsate.

This product has properties and characteristics associated with chemicals detected in groundwater. The use of this chemical in areas where soils are permeable, particularly where the water table is shallow, may result in groundwater contamination. **FATE:**

2,4-D ester rapidly disassociates to the parent acid in the environment. Typical half-life of the 2,4-D acid is from a few days to a few weeks depending on soil type and weather conditions.

Dicamba acid is highly mobile in soil and moderately persistent with a soil half-life of 30-60 days depending on soil type and weather conditions.

Triclopyr BEE ester rapidly hydrolyzes to the parent acid. Triclopyr acid is slightly persistent with a soil half-life of 2 to 6 weeks depending on soil type and weather conditions. Triclopyr acid is water soluble and mobile in soil.

Sulfentrazone is highly persistent with a half-life of 3-18 months depending on soil type and weather conditions. It
