



2G Rates: 1.1 to 3.5 lbs. / 1000 sq. ft. in turf and 2.3 to 4.6 lbs. / 1000 sq. ft. in ornamentals.

3.3 EC Rates: 1 to 2.6 fl. oz. / 1000 sq. ft. in turf and 1.8 to 3.6 fl. oz. / 1000 sq. ft. in ornamentals.

Control Symptoms: Coleoptile growth in grasses is inhibited and emerged shoots are deformed. Small-seeded broadleaf weeds fail to emerge. Root growth is inhibited, especially lateral or secondary roots.

Suggested 2G Tank Mixes

Not applicable. A contact herbicide can be used for burndown of any existing emerged weed species prior to applying **Pendulum 2G**. Consult all label restrictions.

Suggested 3.3 EC Tank Mixes

Drive® 75 DF herbicide for pre- or post-crabgrass and clover control or MSMA , Trimec®, Lesco Three-Way™ or 2,4-D. In ornamentals, Roundup® PRO, Finale® or Ornamec® can be applied.
