## For Use of CIRKIL<sup>®</sup> RTU in Rag in a Bag<sup>™</sup> Protocol against Bed Bugs

**It is a violation of Federal law to use the product in a manner inconsistent with its labeling.**

1. Rag in a Bag<sup>™</sup> treatment can be applied to treat items that cannot be sprayed directly with a liquid product, such as electronics, video games, DVD's, books, or shoes.
2. Place infested items in a non-porous plastic bag such as a heavy-duty garbage bag or contractor bag.
3. Put a non-porous plastic sheet such as grocery bag on top of the infested items to prevent them from coming in direct contact with treated rag.
4. Place a rag(s) or 4 to 5 sheets of highly absorbent paper towel on the protective plastic sheet.
5. Apply 1 to 2 fl.oz. of CIRKIL RTU to approximately 1.5 to 3 sq.ft. of surface area on a rag(s) or absorbent material. Tie the plastic bag and leave it sealed for 5 days to control bed bug adults, nymphs and eggs.

See **Table 1** for appropriate dose of CIRKIL RTU.

**Table 1.** Amount of CIRKIL RTU and time required to achieve 100% Bed Bug/Eggs Mortality in different items

| <b>Bag Contents (items being treated)</b> | <b>Volume of Cirkil RTU (fluid oz.)</b> | <b>Time sealed</b> |
|---|---|--------------------|
| Electronics, hard plastics/metals         | 1.0                                     | 5 days             |
| DVD's, Video Games, CD's                  | 1.0                                     | 5 days             |
| Books, magazines                          | 1.5                                     | 5 days             |
| Shoes, handbags, etc.                     | 1.5                                     | 5 days             |
